In the event Integrated Solutions should commence any action to collect any amounts owing by Customer or any Guarantor, or otherwise seeks to enforce this agreement against Customer or any Guarantor, Customer and any Guarantor consent to jurisdiction and venue in the Orange County, California Superior Court and agree to pay reasonable attorneys' fees, court and other expenses incurred by Integrated Solutions (whether or not a lawsuit is filed). This agreement is not transferable or assignable without prior written consent of Integrated Solutions. This agreement shall become effective upon acceptance by Integrated Solutions. Customer and Customer's authorized representative signing this agreement hereby represent and warrant that the information provided in this application and in any and all additional documents, financial statements or other information furnished by Customer to Integrated Solutions is true and correct in all material respects and contains all information necessary so that this application is not materially misleading. Customer acknowledges that Integrated Solutions is relying on the accuracy of the information provided by Customer. Customer hereby grants Integrated Solutions a security interest in any and all goods purchased by Customer from Integrated Solutions, and in the accounts receivable and proceeds from accounts receivable attributable to Customer's resale of such goods, to secure any and all obligations of Customer to Integrated Solutions, including but not limited to any obligation of payment. Customer agrees to execute any additional documents necessary to perfect or continue any security interest related to this application. Customer also agrees to notify Integrated Solutions promptly and in writing in the event that any of the information provided to Integrated Solutions in or in connection with this credit application materially changes.
